ON 030808 AT APPROXIMATELY 1200 HOURS AT [REDACTED] NORTH 25TH STREET AP1 BUFFALO GALEENER COMMITTED INDECENT EXPOSURE BY EXPOSING HIS PENIS WHILE URINATING AND OFFENDING V1 [REDACTED] WHO WAS STANDING APPROXIMATELY 10 TO 15 FEET AWAY FROM AP1 BUFFALO GALEENER. V1 [REDACTED] COULD PHYSICALLY SEE AP1 BUFFALO GALEENER'S PENIS.

ON 030808 AT 1209 HOURS I WAS DISPATCHED [REDACTED] NORTH 25TH STREET REGARDING AN INDECENT EXPOSURE REPORT. THE CONFRONTATION SQUAD WAS REQUESTING PATROL ASSISTANCE. WHEN I ARRIVED I SAW A GRAY FORD RANGER PICKUP PARKED IN FRONT OF [REDACTED] NORTH 25TH STREET. DETECTIVE RAMIREZ, 3173, WAS INTERVIEWING V1 [REDACTED] BECAUSE SHE WAS NOT AN ENGLISH SPEAKER. I IDENTIFIED V1 [REDACTED] BY HER ARIZONA DRIVER'S LICENSE.

DETECTIVE RAMIREZ 3173 SAID HE WOULD BE THE INTERPRETER FOR THE INVESTIGATION BECAUSE HE SPOKE SPANISH. DETECTIVE RAMIREZ TOLD ME THAT V1 [REDACTED] CAME OUT OF HER RESIDENCE BECAUSE THERE WAS A TRUCK IN FRONT OF HER MAILBOX AND SHE WANTED TO TALK TO THE DETECTIVES WHO WERE PRESENT IN THE AREA ABOUT THE SITUATION INVOLVING THE TRUCK THAT WAS PARKED IN FRONT OF THE MAILBOX. DETECTIVE RAMIREZ SAID V1 [REDACTED] WALKED OUT TO THE 1992 FORD RANGER PARKED IN FRONT OF HER RESIDENCE BLOCKING THE MAILBOX AND STARTED TO WALK NORTHBOUND ON 25TH STREET NEAR THE DRIVER'S SIDE OF THE FORD RANGER. DETECTIVE RAMIREZ STATED V1 [REDACTED] WAS WITH HER 2 YEAR OLD SON [REDACTED] WHEN SHE LOOKED THROUGH THE 1992 FORD RANGER'S FRONT WINDOW THROUGH THE PASSENGER WINDOW AND SAW AP1 BUFFALO GALEENER EXPOSING HIS PENIS AND URINATING IN A CONTAINER. SHE SAID AP1 BUFFALO GALEENER'S PENIS WAS IN HIS RIGHT HAND AND HIS LEFT HAND WAS ON THE CONTAINER. V1 [REDACTED] SAID THERE WERE NO OTHER WITNESSES WITH HER.

IT SHOULD BE NOTED V1 [REDACTED] STATED SHE HAS NO PROBLEMS WITH HER VISION AND SHE DOES NOT WEAR GLASSES AND SHE WAS APPROXIMATELY 10 TO 15 FEET AWAY FROM AP1 BUFFALO GALEENER WHEN SHE SAW HIS EXPOSED PENIS. IT WAS A SUNNY CLEAR DAY.

SERGEANT WATTS, 7048, ARRIVED AT THE SCENE.

I THEN TOOK AP1 BUFFALO GALEENER ACROSS THE STREET WITH ME TO GAIN SOME PRIVACY AND I IDENTIFIED HIM BY HIS ARIZONA DRIVER'S LICENSE. AP1 BUFFALO GALEENER SAID THAT APPROXIMATELY ONE HOUR AGO, WHICH WOULD HAVE BEEN 1115 HOURS ACCORDING TO MY WATCH, HE WENT INSIDE OF HIS TRUCK PARKED AT [REDACTED] NORTH 25TH STREET. HE SAID HE TOOK OUT A CONTAINER AND URINATED INSIDE OF THE CONTAINER. HE SAID THAT V1 [REDACTED] WAS NOWHERE NEAR HIS VEHICLE WHEN HE URINATED. I ASKED AP1 BUFFALO GALEENER IF ANYONE HAD SEEN HIM URINATE AND HE SAID NO, THERE WERE NO WITNESSES THAT SAW HIM URINATING IN THE CONTAINER INSIDE HIS 1992 FORD RANGER PICKUP TRUCK. I ASKED AP1 BUFFALO IF HE WOULD SHOW ME THE CONTAINER WHICH CONTAINED THE URINE. AP1 BUFFALO WALKED ME TO THE TRUCK, OPENED THE DRIVER'S SIDE DOOR. I ASKED AP1 BUFFALO TO KEEP THE CONTAINER BELOW THE DASHBOARD SO THAT V1 [REDACTED] COULD NOT SEE THE CONTAINER. IT SHOULD BE NOTED AP1 BUFFALO KEPT THE CONTAINER VERY LOW SO THAT V1 [REDACTED] COULD NOT SEE THE COLOR OF THE CONTAINER. I ASKED HIM TO OPEN THE CONTAINER AND AP1 BUFFALO OPENED THE TOP LID AND SHOWED ME THAT THE CONTAINER WAS FILLED APPROXIMATELY HALF WAY WITH URINE. I ASKED HIM IF IT WAS URINE INSIDE THE CONTAINER AND HE SAID YES. I TOUCHED THE OUTSIDE OF THE CONTAINER AND NOTICED THE CONTAINER WAS COLD. MY NOSE WAS APPROXIMATELY 12 INCHES FROM THE CONTAINER WHEN HE OPENED THE CONTAINER. I NOTICED A SLIGHT SMELL OF URINE. AP1 BUFFALO CONTINUED TO SAY THAT HE URINATED IN PRIVATE AND THAT NOBODY SAW HIM.

I WENT BACK TO V1 [REDACTED] WHO WAS STANDING WITH DETECTIVE RAMIREZ, 3173. I ASKED [REDACTED] IF SHE PHYSICALLY SAW HIS PENIS. V1 [REDACTED] STATED THAT SHE DID THOROUGH THE INTERPRETATION OF DETECTIVE RAMIREZ. SHE SAID HIS PENIS WAS NOT INSIDE OF THE CONTAINER AS HE WAS URINATING. SHE SAID HIS PENIS WAS ABOVE THE CONTAINER WHERE SHE COULD VISUALIZE IT. I ASKED HER WHAT COLOR THE CONTAINER WAS. SHE SAID THE CONTAINER WAS BLUE WITH A YELLOW LID. V1 [REDACTED] SAID SHE WOULD TESTIFY AND ASSIST IN PROSECUTION. SEE DETECTIVE RAMIREZ, 3173, SUPPLEMENTAL REPORT FOR MORE DETAILS OF THE INTERVIEW WITH V1 [REDACTED]

AP1 BUFFALO GALEENER WAS CITED WITH COMPLIANT #13751189 FOR INDECENT EXPOSURE, ARS 13-1402, A CLASS 1 MISDEMEANOR. HE SIGNED THE CITATION AND STATED HE AGREED TO APPEAR IN COURT ON 031808 AT 2:30 P.M. IN THE PHOENIX MUNICIPAL COURT. I FINGERPRINTED AP1 BUFFALO GALEENER ON THE C.L.D. AND ASKED HIM IF EVERYTHING WAS CORRECT INCLUDING HIS NAME, SOCIAL SECURITY NUMBER AND DATE OF BIRTH. AP1 BUFFALO GALEENER STATED THAT EVERYTHING WAS CORRECT ON THE CITATION.

ON MONDAY MARCH 17TH, 2008 I RECONTACTED MS. ████████ AT HER RESIDENCE TO ASK HER ████████ SOME ADDITIONAL QUESTIONS REGARDING THIS INVESTIGATION. I ASKED MS. ████████ TO TELL ME WHY SHE ████████ HAD EXITED HER RESIDENCE. MS. ████████ EXPLAINED THAT SHE ████████ WANTED TO TALK TO THE OFFICERS ABOUT THE TRUCK THAT WAS PARKED IN FRONT OF HER (████████) RESIDENCE AND IN FRONT OF THE MAILBOX DUE TO THE FACT THAT AT TIMES MAIL HAS NOT BEEN DELIVERED TO HER HOME.

I THEN ASKED ████████ IF HER SON HAD ACCOMPANIED HER (████████). MS. ████████ TOLD ME THAT WHEN SHE EXITED THE HOUSE, HER TWO (2) YEAR OLD SON WALKED AND FOLLOWED BEHIND HER ████████. MS. ████████ ADDED THAT AS SHE CROSSED THE FRONT YARD OF THE RESIDENCE AND PROCEEDED TOWARD THE GATE THAT LED TO THE STREET (N. 25TH STREET) SHE SAW THAT SUSPECT GALEENER WAS STANDING IN FRONT OF THE PASSENGERS SIDE DOOR ADDING THAT MR. GALEENER WAS BETWEEN THE PASSENGER DOOR AND THE ENTRANCE INTO THE PASSENGER COMPARTMENT OF THE TRUCK. MS. ████████ TOLD ME THAT SUSPECT GALEENER TURNED AND LOOKED AT HER (████████) BUT MADE NO ATTEMPTS TO STOP AS TO WHAT ACTIVITY HE (GALEENER) WAS DOING AT THE TIME. MS. ████████ ADDED THAT SHE ████████ DID NOT KNOW WHAT SUSPECT GALEENER WAS DOING STANDING BY THE TRUCK.

MS. ████████ CONTINUED BY SAYING THAT AS SHE WALKED PAST THE FRONT END OF THE FORD RANGER TRUCK AND ARRIVED TO THE AREA OF THE DRIVERS SIDE WINDOW OF THE TRUCK (FORD RANGER) THAT WAS PARKED IN FRONT OF HER HOME SHE ████████ TURNED HER HEAD SO AS TO CHECK ON HER SON THAT WAS WALKING AND FOLLOWING BEHIND HER ████████. MS. ████████ TOLD ME THAT IN TURNING HER HEAD SHE ████████ SAW SUSPECT GALEENER URINATING INTO A CONTAINER. I THEN ASKED HER (████████) IF SHE WAS CERTAIN WHAT SHE ████████ HAD SEEN AND WITNESSED. MS. ████████ SAID, "YES" WITHOUT HESITATION. MS. ████████ SAID THAT SHE WAS SURPRISED AS TO WHAT SHE HAD JUST SEEN AND WITNESSED SO SHE ████████ QUICKLY LOOKED AGAIN TO ASSURE HERSELF (████████) THAT SUSPECT GALEENER WAS IN FACT URINATING AND INTO A CONTAINER. MS. ████████ SAID THAT SHE ████████ DEFINITELY DID SEE AND DID WITNESS SUSPECT GALEENER URINATING. I, AGAIN ASKED HER IF SHE RECALLED WHICH HAND SUSPECT GALEENER WAS HOLDING HIS (GALEENER) PENIS. MS. ████████ SAID WITHOUT HESITATION THAT SUSPECT GALEENER WAS HOLDING HIS (GALEENER) PENIS WITH HIS RIGHT HAND AND WAS HOLDING THE CONTAINER WITH HIS LEFT HAND.

MS. [REDACTED] ADDED THAT SHE LOOKED A THIRD TIME AND AT SUCH TIME SUSPECT GALEENER WAS PLACING THE TOP ON THE CONTAINER HE (GALEENER) HAD USED TO URINATE INTO. MS. [REDACTED] WENT ON TO SAY THAT SHE DID NOT WANT TO LEAVE FROM WHERE SHE [REDACTED] WAS STANDING SO THAT SHE [REDACTED] COULD TELL THE TRUTH.

I, AGAIN ASKED MS. [REDACTED] IF SHE [REDACTED] HAD SEEN SUSPECT GALEENER URINATING. MS. [REDACTED] SAID, "YES" SAYING THAT SHE HAD SEEN AND WITNESSED THE INCIDENT AS SHE STOOD BY THE DRIVERS SIDE WINDOW OF THE TRUCK. MS. [REDACTED] SAID THAT SHE LOOKED THRU THE WINDOW AND AT SUSPECT GALEENER AS HE STOOD BY THE PASSENGER SIDE OF THE TRUCK.

I ASKED MS. [REDACTED] IF SUSPECT GALEENER MADE ANY ATTEMPT TO CONCEAL HIMSELF FROM HER. MS. [REDACTED] SAID, "NO." I HAD NO ADDITIONAL QUESTIONS FOR MS. [REDACTED] SO I CONCLUDED THE INTERVIEW AT 1550 HRS. ON 3/17/08. I COMMENCED SPEAKING WITH MS. [REDACTED] AT 1510 HRS.

IT SHOULD BE NOTED THAT THERE IS A "MCDONALDS" RESTAURANT AT THE SOUTHWEST CORNER OF 2500 E. BELL ROAD AND A "TACO BELL" RESTAURANT JUST TO THE WEST OF THE MCDONALDS THAT CONTAIN RESTROOM FACILITIES.

THIS SUPPLEMENT IS BEING GENERATED FOR THE PURPOSE OF PROVIDING ADDITIONAL INFORMATION ON THE INCIDENT THAT OCCURRED ON SATURDAY MARCH 8TH, 2008 AT [REDACTED] N. 25TH STREET.

ON SATURDAY MARCH 8TH, 2008 WHILE WORKING AN ON-GOING "DAY LABOR" PROTEST DIRECTED AT THE "MACEHUALLI WORK CENTER" I WAS ASKED BY DET. JEFF WOOD #4533 TO PROCEED TO HIS LOCATION FOR THE PURPOSES OF PROVIDING TRANSLATION FOR AN INCIDENT THAT HAD JUST OCCURRED. THE HISPANIC FEMALE INDIVIDUAL WHO WAS REQUESTING OUR ASSISTANCE DID NOT SPEAK ENGLISH. I WALKED OVER TO THE FEMALE INDIVIDUAL, WHO WAS STANDING BY A FORD RANGER. THE FEMALE INDIVIDUAL, LATER IDENTIFIED AS [REDACTED] APPEARED TO BE UPSET. I ASKED HER IN SPANISH WHAT HAD OCCURRED. [REDACTED] SAID THAT SHE HAD SEEN AND WITNESSED A MALE INDIVIDUAL, LATER IDENTIFIED AS RICK GALEENER STANDING BY THE "FORD RANGER" TRUCK URINATING INTO A CONTAINER. I THEN ASKED [REDACTED] IF SHE WAS SURE AND POSITIVE IN WHAT SHE HAD SEEN. [REDACTED] SAID, "YES." I THEN ASKED [REDACTED] S IF SHE HAD SEEN HIS "THING" (PENIS). AGAIN, [REDACTED] SAID, "YES." SINCE THIS INCIDENT INVOLVED A CRIMINAL MATTER, A PATROL OFFICER WAS REQUESTED VIA POLICE RADIO. WHEN OFFICER SULLIVAN #8748 ARRIVED I TOLD HIM (SULLIVAN) WHAT HAD TRANSPIRED AND TOLD HIM THAT [REDACTED] WANTED TO PROSECUTE AND PERSUE THIS MATTER. I WENT ON TO TELL OFFICER SULLIVAN THAT [REDACTED] DID NOT SPEAK ENGLISH WELL SO I WOULD TRANSLATE FOR HIM (SULLIVAN).

IN TALKING TO [REDACTED] I WAS TOLD THAT SHE CAME OUT OF HER RESIDENCE TO TALK TO THE OFFICERS ABOUT THE TRUCK THAT WAS PARKED IN FRONT OF HER [REDACTED] MAILBOX. [REDACTED] ADDED THAT SHE WANTED TO DISCUSS THE PARKING SITUATION WITH OFFICERS BECAUSE OF THE DIFFICULTY IT POSES FOR THE DELIVERY OF HER MAIL. [REDACTED] WENT ON TO SAY THAT AS SHE ([REDACTED]) WAS CROSSING THE FRONT YARD OF HER [REDACTED] RESIDENCE AND WALKING TOWARD THE GATE SHE SAW SUSPECT GALEENER STANDING BY THE PASSENGER DOOR OF THE FORD RANGER. THE VEHICLE (FORD RANGER) AT THE TIME WAS PARKED ALONG THE WEST CURB OF N. 25TH STREET AND FACING SOUTHBOUND AND PARKED IN FRONT OF THE [REDACTED] RESIDENCE.

HIS (GALEENER) PENIS AND URINATING INTO A CONTAINER. I THEN ASKED MS. [REDACTED] IN WHICH HAND WAS SUSPECT GALEENER HOLDING HIS "THING." MS. [REDACTED] TOLD ME, IT WAS HIS (GALEENER) RIGHT HAND AND THAT GALEENER WAS HOLDING THE CONTAINER WITH HIS (GALEENER) LEFT HAND. I THEN CONTINUED BY ASKING MS. [REDACTED] HOW SHE [REDACTED] CAME ABOUT SEEING SUSPECT GALEENER EXPOSING HIS (GALEENER) PENIS AND URINATING. MS. [REDACTED] SAID THAT AS SHE CROSSED THE FRONT END OF THE FORD RANGER AND REACHED THE AREA OF THE DRIVERS SIDE WINDOW SHE SAW SUSPECT GALEENER STANDING BY THE PASSENGER DOOR AND WITNESSED SUSPECT GALEENER URINATING INTO A CONTAINER. MS. [REDACTED] ADDED THAT IN SEEING SUSPECT GALEENER URINATING SHE THEN WAVED TOWARD THE OFFICERS TO GRAB THEIR ATTENTION SO AS TO INFORM THEM AS TO WHAT SHE HAD JUST WITNESSED.

I CONTINUED WITH MS. [REDACTED] BY ASKING HER IF SHE RECALLED THE COLOR OF THE CONTAINER THAT SUSPECT GALEENER WAS HOLDING AT THE TIME HE (GALEENER) WAS URINATING. MS. [REDACTED] SAID THAT THE "BODY" OF THE CONTAINER WAS BLUE AND THE LID WAS YELLOW ADDING THAT THE LID WAS YELLOW. I ASKED MS. [REDACTED] IF THERE HAD BEEN ANY OBSTRUCTION BLOCKING HER LINE OF SIGHT THAT PROHIBITED HER [REDACTED] FROM SEEING MR. GALEENER URINATE. MS. [REDACTED] SAID, "NO." I THEN ASKED MS. [REDACTED] IF SHE HAD ANY EYE/VISION PROBLEMS OR WORE ANY FORM OF CORRECTIVE LENSES. AGAIN, MS. [REDACTED] SAID, "NO." I THEN FINISHED WITH MS. [REDACTED] SINCE NO ADDITIONAL QUESTIONS WERE ASKED.
